NOTICE OF PRIMARY ELECTION

The Board of Elections of Fairfield County, Ohio issues this Proclamation and Notice of Election.

A PRIMARY ELECTION WILL BE HELD ON

TUESDAY, the 6th day of March, 2012 at the usual place of holding elections in each and every precinct in Fairfield County or at such places as the Board may designate, to:

choose delegates and alternates to National Convention; to choose the following officers: for the State of Ohio, U.S. Senate; Justice of the Supreme Court, full term commencing 1/1/2013; Justice of the Supreme Court, full term commencing 1/2/2013; Justice of the Supreme Court, unexpired term ending 12/31/2014; Representative for the 15th District US Congress; Senator for the 20th District of the Ohio Senate; Democratic State Central Committee, Woman, 20th District; Democratic State Central Committee, Man, 20th District; Republican State Central Committee, Woman, 20th District; Republican State Central Committee, Man, 20th District; Representative for the 77th District Ohio House of Representatives; Representative for the 78th District Ohio House of Representatives; Justice of the 5th District Court of Appeals, full term beginning 2/9/2013; Justice of the 5th District Court of Appeals, full term beginning 2/10/2013; Justice of the 5th District Court of Appeals, full term beginning 2/11/2013; for Fairfield County: Judge of Court of Common Pleas General Division, full term commencing 1/1/2013; Judge of Court of Common Pleas, Domestic Relations Division, full term commencing 1/2/2013; County Commissioner, full term commencing 1/2/2013; County Commissioner, full term commencing 1/3/2013; County Prosecutor; County Clerk of Courts; County Sheriff; County Recorder; County Treasurer; County Engineer; County Coroner; Democratic and Republican Central Committee Members

For City of Lancaster, 0.15% income tax, operate, maintain, repair and provide capital facilities for municipal park and recreational activities and facilities, 5 years, Renewal; Village of Sugar Grove, tax levy, 4 mills, operating expenses, 5 years, Renewal; Lancaster City School District, Bond issue, \$61,550,000 (est 3.6 mills), construction and renovation, 37 years, and a 0.5 mill tax levy, permanent improvements, for a continuing period of time, Additional; Baltimore Village, Precinct B, Broken Spoke Garlic LLC, 108 North Main Street, Baltimore, a site specific local option for wine and mixed beverages and spirituous liquor; Baltimore Village, Precinct B, Broken Spoke Garlic LLC, 108 North Main Street, Baltimore, a site specific local option for Sunday sales of beer, wine and mixed beverages, and spirituous liquor; City of Lancaster, Second Ward Precinct B, WalMart Stores East LP, 2687 N. Memorial Dr., Lancaster, a site specific local option for Sunday sales of wine and mixed beverages, off premise; Pataskala Public Library (Southwest Licking School District), tax levy, renewal of one-half (0.5) mill and an increase of one-quarter (0.25) mill, current expenses, 5 years, Renewal and Increase; Teays Valley Local School District, income tax, 1.5 %, current expenses, for a continuing period of time, Replacement.

The polls for the election will open at 6:30 a.m., and remain open until 7:30 p.m. on election day.
