Notice of Primary Election R.C. 3501.03

Township: Clearcreek Township, .5 mill, roads and bridges, 5 years, renewal. Violet Township, 4.6 mills, parks and recreation, 25 years, additional.


Schools: Amanda-Clearcreek LSD, 1% income tax, current operating expenses, 5 years, new. Canal Winchester LSD, 12.59 mills, providing for the necessary requirements of the school district, 5 years, substitute. Lancaster CSD, constructing school facilities and renovating existing facilities, \$66,125,000.00 bond repaid annually estimated at 3.7 mills, 37 years, new. Walnut Township LSD, 6.3 mills, emergency requirements of the district, 5 years, renewal.

Municipal: City of Columbus; Health and Safety, \$205,000,000.00 bond repaid annually estimated at .91 mill, 22 years, new. Recreation and Parks, \$100,000,000.00 bond repaid annually estimated at .53 mill, 17 years, new. Public Service, \$425,000,000.00 bond repaid annually estimated at 2.33 mills, 16 years, new. Public Utilities, \$250,000,000.00 bond repaid annually estimated at 1.03 mills, 25 years, new. Neighborhood and Community Development, \$50,000,000.00 bond repaid annually estimated at .24 mill, 20 years, new. Village of Buckeye Lake, 5 mills, police protection, 5 years, additional. Village of Buckeye Lake, current expenses of the Village, 1 mill, 5 years, renewal. Village of Stoutsville, current operating expenses, 2 mills, 5 years, renewal.
